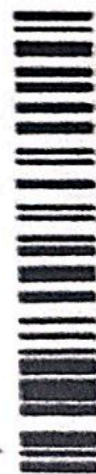

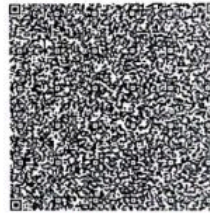

Bone Marrow Transplantation is the only chance of cure for this child. He has no matched sibling or related donor. We have found a fully Matched Unrelated Donor (MUD) through Bone Marrow Registry (DATRI). He is posted for MUD Allogenic Hematopoietic Stem Cell Transplant in the last week of February 2025 at our Centre. The cure rate after MUD Allogenic HSCT is 80-90%. The estimated cost of MUD Allogenic HSCT at our centre is approximately Rs. 18,00,000/- (INR Eighteen Lakhs).




